2023 Awards Banquet and Holiday Party?

Only 30 attended our 2022 Awards Banquet & Holiday Party held last December. That's not a particularly good turnout. The hit the treasury took made the evening a bit more expensive than planned. The poor attendance is a concern. Likewise, it wasn't possible to glean much guidance from the few at our January membership meeting.

A brief bit of background. Due to COVID-19 ripples, the 2020 and 2021 awards were presented at Smitty's. Only those receiving awards or service plaques were invited to attend. From 2014 through 2019, the average attendance at our awards banquet & holiday party was 43. The minimum was 36 and the most was 45. The 45 happened twice in those six years. Historically, the treasury expects an \$800 to \$1000 loss on the event. For 2022 the number was \$1461. Our traditional night for this event has been the first Friday of December.

At the February membership meeting (on Wednesday the 15th), the board hopes to be able to get sufficient feedback from the membership to be able to develop a plan for a well-attended 2023 awards banquet event. Some of the open questions are:

- Are people no longer interested in a dressy night out celebrating a year of SIR competition?

- How important is the "county club" environment to attendees?

Think of a nice setting, sit-down meal, and people dressed up.

- Would you prefer a more causal event?
- Have we reached a price point that discourages attendance?
- The 2022 price was \$49 for the beef entrée \$43 for either the chicken or fish option.

- What is your idea for a fair price to attend an awards banquet & holiday party?

The price has included dinner, two bar drinks, a soft drink, and a "mean Santa" game for years.

- Should we:

Change to an awards banquet party in January?

- OR -

- Stay with a December awards banquet & holiday party?
- Did concerns about gathering indoors with COVID-19 and RSV infections prevalent keep you from attending?
- Do you believe an annual gathering to transition from one board to another and celebrate the presentation of the region's championship awards is worth continuing?
- Did having to register and pay through MotorsportReg.com keep you from attending?
- Please join us at Smitty's on the 15th to share your thoughts and voice your opinion on the 2023 awards banquet. We'll gather at 5:45 P.M. to socialize and eat dinner. The business meeting will begin at 7:00.

<u>Notes from the Director's Chair</u> <u>Area 4 Director Update for February 2023</u>

I apologize for the tardiness of this edition, but I just returned from attending the Rolex 24 at Daytona and it was quite a week down there. A few adult beverages were consumed, and I got a bit of a sunburn.

As you can see from the number of items below, January was a very busy month for Zoom calls on my calendar. As I mentioned last month, there's no such thing as an off season....there is just the preparation for the next season.

Video Conference Meetings:

- Club Racing Board (CRB) (1/3): We finalized plans for a second face to face meeting in 2023 which would be held in March (3/24, 3/25). The group reviewed changes in the data acquisition program. We also discussed ways to streamline the flow of information to and from the CRB and the BoD. The results of CRB rules changes can be seen <u>here</u>.
- Electrified Vehicle Advisory Committee (EVAC) (1/5): We added an additional meeting to consider the letters that had been sent to the EVAC through the CRB letter portal. There were several letters the EVAC had received about the SCREV and our Club Racing rules packages that needed extended conversation. The good news is that the members are asking serious questions of us, and this proves they are engaged on the topic.
- EVAC (1/11, 1/16): Due to some technical difficulties, our meeting was cut short on 1/11 so we were forced to add another meeting on 1/16 to continue the discussion. We chatted about the EVAC update session for the convention. We also got an update about safety training that would be required for the members who would interact with EVs at competition events.
- Board of Directors (BoD) (1/17): This was an additional meeting convened to deliberate on one topic. We discussed how to alleviate the turmoil in the Rally Cross program and the best way to right the ship.
- Great Lakes Division (GLDiv) (1/18): Several of us met to discuss the planning and schedule for the GLDiv Spring Training Meeting in Fort Wayne next month. Val McCammon updated us on what she had done so far and we chatted about how to enhance the experience for the members.
- SCCA Convention (GLDiv Meet & Greet Session) (1/21): Several of us hosted a convention session for the GLDiv members. The idea was to give out information about the division officials and allow them to dispense aspects of each of the competition programs in the division. I started by showing slides of the officers and officials for the division. I was followed by Lauri Burkons as she chatted about the Club Racing program. Ray Jason, Velma and Raleigh Boreen reviewed the details of the upcoming Solo season. Vinnie Taibi passed on specifics about the Time Trails program. According to post event statistics, we had 80 people attend the session. If you'd like to view it, you can watch the session by following this link.
- SCCA Convention (EVAC Session) (1/23): I hosted a session where we updated everyone on what the EVAC has been up to as well as where we are headed. 154 people tuned in for this one and it can be seen by following this <u>link</u>.

- BoD (1/30): As this was our first "normal" meeting of the year, we discussed items on a wide variety of topics:
 - 1. The reorganization of the RallyCross Board (RXB)
 - 2. Addition of a member to the SCCA Foundation Board
 - 3. The revised Enduro rules package
 - 4. The Dallas, TX meeting of the Solo Events Board (SEB)
 - 5. We approved the members of the Time Trails Board (TTB)

We also looked for ways to enhance communication between the Club Racing Board (CRB) and the steward corps.

SCCA Events:

Rolex 24 Hour Race: While not strictly speaking an SCCA event, part of my rationale for going to this event was to see how the SCCA supports this race. I saw many SCCA members there and conducted some business during the race too. Like a lot of pro races, the SCCA supplies most of the corner workers. With a "4 hours on, 8 hours off" regimen, there needs to be scores of workers for this event and the vast majority are SCCA members. I roamed the grounds and spoke with the staff at several corners and found out they were from all corners of the country and even a few from overseas.

A quick reminder that the GLDiv Spring Meeting will occur on 3/3 and 3/4 in Fort Wayne, IN at the same site as last year (Manchester University). A link for registering for the event can be found <u>here</u>. The registration cost is \$30. An additional \$10 gets you a really nice pasta, salad and dessert dinner from Casa d'Angelo on Friday evening. The meetings will be across all programs, so I encourage all members to attend. With more programs under the SCCA banner these days, we need to focus on teamwork to help each region put on the best events they can.

As usual, Val McCammon is coordinating the event. She told me the agenda will be posted on MSR in a few days. She asked me to let our members know that seven SCCA National Staff will be attending our meeting to aid in enhancing our divisional programs.

She also asked that I remind folks to contact her (<u>pyramid@bluebirdview.com</u>, 260.437.6707) with any questions you may have about the meeting.

I retired last summer so I have plenty of free time and would thoroughly enjoy the chance to visit with your members.

Rally & Motorsport Park-our official test track, as you may have heard-doing some testing on a couple of project cars. Tom was trying out some different flash tunes on his Mk7 VW GTI, and I was taking Tim's Porsche 997 for a few laps after we'd fit a set of Bridgestone RE-71RS tires on some snazzy Apex wheels.

I'll let the respective daddies of those project cars tell you how those mods affected their charges. (Check out our online updates after you finish reading this.) Besides, that's not the point of this column.


See, after I brought Tim's Porsche back safely from some timed laps (as an aside, I could do an entire column on appropriate aggression levels and risk management when driving your boss's 911 on a race track while he's totally standing *right there*), we got into a chat with a couple of guys who were there enjoying their own cars during this open-track Friday.

One of them was driving his own Porsche 997, but this was one of the factory hotrod GT3 variants: more power, tricker suspension, rear seat delete and all that historical Porsche factory racing goodness baked right into the recipe. Naturally, we were curious how Tim's car compared to the hotter version.

"So what kind of lap times are you doing here?" Tim asked the GT3's owner.

"Okay, first," Mr. GT3 began, which is an awesome way to start answering any question that you either don't know or don't like the answer to, "the only other time I had it here, I was on Pilot Super Sports, and one of the date





codes was 2018, one was 2019, and I don't even know what the other two were, and later we found out that the left rear was toed way in, and also on the way here I saw a donkey, and that reminded me of a time when I was a kid and I got lost in a department store and they called my name on the store intercom but they mispronounced it so I didn't know they were talking about me and I ended up joining the Canadian national fencing team. So anyway, what was the question?"

Maybe that's not a direct quote, but look, his response was a looong list of asterisks that I don't recall ending in a numerical lap time. Mr. GT3, if you're reading this, please know I'm not busting your hump here, but rather recalling this interaction with only the greatest of affection because it reminded me of something I love about this sport and this world: the sheer complexity of it.

For the most part, we're just regular folk, going about our hobby, but our hobby has so, so, so many variables. To actually sit down and think about it is just staggering.

For a single driver to complete a single lap at a single track day, a complex machine–possibly one that the regular-type person I just mentioned turned a wrench or two on, complicating matters even more–has to combine all of its hundreds of thousands of pieces of engineering wizardry to be operated by a driver who is negotiating the interface of a tire and a road surface at a molecular level countless times a second around a course with a finite number of turns but requiring an infinite number of control inputs and real-time decisions leading to those control inputs.

That we-literally any of us who don't do this for a livingcan actually successfully negotiate a lap or two anywhere near the limit of performance, wrangling the mechanics, physics and psychology of an irreducibly complex operation, is nothing short of a miracle.

At the end of the day, that lap time that we asked about is but one single metric in a vast ocean of tumblers that must align with perfect precision so we can unlock our experiences in this sport.

So, Mr. GT3, you may not have told us a time-or, if you did, I certainly don't remember-but you told us a story that was maybe more important. And that story is that before you can even *think* about a lap time, you have to wrangle the existential chaos of even the simplest of motorsport into some sort of order.

And for us regular folk, living our lives and doing our jobs and tending our literal or metaphoric flocks, having a hobby based on an inconceivable number of variables, any of which could turn the experience into a nightmare, the fact that we manage to do this is some sort of victory.

I mean, look, you could have just said "1:19," but how boring would this column have been?







THE MAD PROGRAMMER



The final organizing meeting for the 1979 Interserie, the Indiana State Autocross Championship Series, was held in Indianapolis on January 20. SIR was represented by Tom Bootz, George Groenert, and Fred Pendley. Representatives from the other participating organizations, Indy Motor Sports Club (IMSC), Columbus Sports Car Club (CSCC), Indy Region SCCA, and Sports Car Club of Central Indiana (SCCCI) were also in attendance. Final details of the series were worked out, and it appears the 1979 Interseries will be one of the Midwest's premier autocross series.

For 1979, the classes will be: Pure Stock (SCCA Solo II Stock), Pro Stock (SCCA Solo 11 Prepared w/ street tires), Prepared (SCCA Solo II Prepared), Modified, and Ladies. A safety committee composed of one representative from each member club will supervise course layout, course safety, car classification, and protests.

There will be five events with each event's finish contributing to the entrant's final score for the series. Tentative event dates and locations are as follows:

The drumming of the engine, And the song of flying wheels, As we ride to find the freedom That the weary world conceals...


And all we have before us Are the highway and the sky... A wild and empty line of road, And fences flashing by...


Updating from last month, we find USAC and CART still at odds over the 1979 Champ Car season. USAC has now published a tentative schedule of races. More importantly, USAC seems to be willing to try and solve one of the biggest problems that caused the initial split. USAC has proposed use of stock-block engines for the Champ Cars. The Club hopes that this move would not only reduce costs, but also restore some parity among the teams. NASCAR has used stock-blocks for many years and has traditionally featured nose-to-tail racing. Fans and especially the media, have complained about the lack of real racing in the Champ Cars in past seasons. For those of you who haven't spoken to yours truly since January 20th, I'm in the midst of a career change. Now that I'm out of the new car wars and no longer have an axe to grind, herewith are some tidbits for those of you who may shortly be in the market for a new machine.

DEAD LAST

Generally speaking, January and February are slow months for auto dealers due to poor weather. A new car buyer can use this fact to his advantage if it is possible to buy before peak season in spring. The dealer still needs to move cars, so you may be able to get a sweeter deal while dealership traffic is slow. Certain high demand cars will continue to sell well, but you should have more bargaining power now than in the spring when sales begin to increase.

Higher production costs and the shrinking dollar are forcing price jumps on all cars. Thus, you may well save \$100 or more if you can beat a price increase. Add rising interest rates for new car loans to the previous two factors, and it's possible that buying now can save a substantial amount compared to spring when higher demand, price increases, and interest rates drive new car costs higher.
